## "Help Hire a President"

Our first membership meeting for this fall promises to be a stimulating pre-election/post-debate session featuring *New York Times* columnist Clyde Haberman. Come to hear the views of this lively writer on the Presidential election and the effects of the old and new media on political campaigns.

Long time League members will remember a Presidential election campaign decades ago, when the subways and buses were filled with League of Women Voters cards saying **Help Hire a President**. Our Telephone Information Service was overwhelmed with calls about the primaries, how to register, where to vote, and how to get in touch with a candidate's campaign headquarters. Today we are still getting the phone calls and voters can also get that information from the traditional sources of newspapers, television, and direct mail, but more and more are turning to the internet.

In addition to YouTube, Facebook, and email, television and radio outlets have websites where you can hear the speeches, see the political ads, and catch the commentators' spins and opinions in case you missed them in real time. As the parties and civic groups work overtime to ensure that newly registered voters go to the polls on November 4<sup>th</sup>, we wonder what impact will these new sources have on the outcome of the election.

The meeting will also provide time for a look back at the debates, a review of the November ballot, including other candidates for president, races for Congress and the State Legislature, and the one statewide ballot issue. Come prepared for a lively discussion.

## New Voter Education Portal for All Things Electoral

Not sure if you are registered to vote? Wondering about the new ballot-marker voting machines? In doubt about your polling place? For answers to these and other questions about the election process, go to the new voter education portal of the State Board of Elections, [www.vote-ny.com](http://www.vote-ny.com).



You can also check your voter registration status online by going directly to the BoE website, [www.elections.state.ny.us](http://www.elections.state.ny.us). Click on Voting Information on the left, then on "Look up your voter registration." You will be asked to type in your name, date of birth, county and zip code. From there, you will receive a prompt to link to the City Board's Poll Site Locator.

For those who do not have access to the internet, it is also possible to check your registration status by calling the NYC Board of Elections on 212-VOTE-NYC.



## Don't leave home without ... registering to vote

## Ballot Marking Devices Headed For Each NYC Polling Place

While the struggle continues to bring a Secure, Accurate, Recountable, and Accessible voting system to New York State, there will be at least one Ballot Marking Device (BMD) at each polling place on November 4, in addition to the mechanical voting machines which have been in use for more than 40 years. These BMDs will enable voters with disabilities to cast a secret ballot independently in the same place and in the same manner as their neighbors.



Any voter can use the BMD but it will be particularly helpful to a voter with a disability who will be able to view or listen to the ballot in any of the required languages (English, Spanish, Korean and Chinese – Mandarin or Cantonese) and then use either the ATM-style touch screen, Braille-enhanced keypad, sip-and-puff device, or rocker paddles to mark the ballot. The voter will then deposit the ballot in a box, to be counted by hand at the end of the day. The Board of Elections plans to have specially trained inspectors in each polling place to assist voters with the BMDs. A video and instructions on how to use the AutoMark device can be found on the NYS Board of Elections website [www.vote-ny.com](http://www.vote-ny.com). The NYC Board will hold demonstrations of the ballot markers and we will post those dates on our website, [www.lwvny.org](http://www.lwvny.org), as they become available.

The next step in this process, the replacement of all our old voting machines, is scheduled to be completed in time for the 2009 elections. The only system which meets the requirements of NYS law and the standards established by the State Board of Elections is one which uses paper ballots with precinct-based optical scanners in conjunction with ballot markers. The League has long advocated for this type of system and also for the strict testing and high standards adopted by the Board, which are the highest adopted by any state. However, the certification and testing process continues to find faults in the machines under consideration.

As Bo Lipari, the League's representative on the State Board of Elections Citizen Election Modernization Committee, has said, "The good news is that we're identifying problems prior to an election – *the machines are failing New York's tests*. New York State will not use these machines until such time as they meet the standards required by law and regulation. In other words, *the process is working*."

# The Candidates Are Talking -- Are You Listening?

Having completed another offering of our popular course, "How to Run for Public Office," at LaGuardia Community College in July, the League has now designed a seminar for graduates of the course which will be based on the **2008 Presidential Debates**. Supported by a grant from New York Community Trust, we will conduct a five-week interactive guide to the debates on the internet which will also be open to League members.

The course will begin on September 22<sup>nd</sup> and conclude on October 17. Participants will review the history of the debates and see examples from past years. They will then watch the live debates and participate in online discussions, guided by League instructors.

Tuition for full participation in the course is \$20.08, which includes a copy of the LWVUS guide to the electoral process, *Choosing the President 2008*. Registration is open at our special website, [www.LeagueandLearnNYC.org](http://www.LeagueandLearnNYC.org), which was designed by Alison Alpert and project coordinator Ashton Stewart.

All the information you will need to fulfill this assignment, including the location of your assigned polling place, will be sent to you by AP a few days before Election Day.

## The Board of Elections Needs YOU

In anticipation of a record turnout of voters at the November election, the NYC Board of Elections is accepting applications from residents of voting age who would like to work at the polls on November 4.

Vacancies exist in all four categories: inspector/poll clerk, interpreter, information clerk, and door clerk. Every poll worker is required to take one training class and to work at a polling site to which she will be assigned from 5:30 a.m. until at least 9:00 p.m. on November 4. She will be paid \$200 for the day, plus \$25 for attending the training class.

## Report from the Annual Meeting

On May 31, members of the LWVNYC gathered for our 2008 annual meeting, the last one to be held at the Workmen's Circle building on 33<sup>rd</sup> St. A review of the past year included the record-breaking award luncheon, consensus on immigration reform and the move to our new location at 150 Broadway. Following the business meeting, members heard a stimulating address by guest speaker Jonathan Landay (see photo right).

The challenging agenda required decisions that will help guide the League through the years to come. Members approved a newly organized budget which clarifies the separate roles of the League of Women Voters membership organization and our Education Fund. Donna Landay, chairman of the nominating committee, presented a slate of new officers and directors, which now provides for a five-person management team (see page 2). Proposed program for the coming year included a new study of Instant Runoff Voting, continuation of our study of National Popular Vote, and further review of Community Boards.

### What the League will be studying this year

#### **Instant Runoff Voting**

In anticipation of the 2009 municipal elections, when there may be multiple candidates in the primary election for the offices of Mayor, Comptroller, and Public Advocate, the City's method of dealing with races where no candidate for these offices receives 40% of the vote is coming under scrutiny. The present system, which would require a runoff primary three weeks after the Primary Election, runs the risk of an extremely short time frame if there are candidate challenges and recounts. In addition, a second primary is extremely costly to the candidates, the campaign finance board, and to the City.

Our new study, which will be chaired by Adrienne Kivelson, will look at alternative methods of voting, including Instant Runoff Voting (IRV). In this system, voters rank their choices for each office in order of preference the first time they vote. If no candidate receives the required percentage of the vote, the candidate with the lowest number is dropped and the second choices of the voters who voted for that candidate are redistributed. This process is repeated until one candidate has achieved the required percentage.

Leagues in California, Florida, North Carolina, Michigan, and Massachusetts have studied alternative election systems and now support Instant Runoff Voting. In NYC, a study committee will be looking at the subject from all sides and will present its material to members at a meeting in the spring, in the hope of reaching consensus on whether IRV would be preferable to the current method of runoff primaries. #### **Community Boards in New York City**

The Community Board study committee, under the leadership of Fannie Conner, will continue its review of the community boards in all five boroughs, with particular attention to their budgets and the various ways in which they publicize their meetings and decisions to their constituents. In addition, every member can participate in the study by attending one or more of the monthly meetings of her own Community Board and sharing her observations with the committee. #### **National Popular Vote**

Building on our preliminary study of the National Popular Vote last winter, we will proceed to the next steps in our evaluation of this possible alternative to the Electoral College. We will be aiming for a consensus on this issue by May 1.

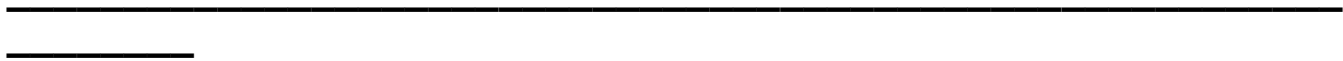
